Pursuant to the provisions of Section 607.1105 of the Florida Business Corporation Act, the undersigned does hereby adopt, and the surviving corporation delivers for filing, the following Articles of Merger for the purpose of merging Wasserman & Wexler, LLC, a Florida limited liability company (the "Merging Company"), with and into JM Insurance Agency Partners, Inc., a Florida corporation (the "Surviving Corporation").
