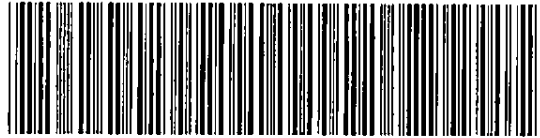

ARTICLES OF INCORPORATION
OF
QUALLS BROTHERS, INC.

We the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the laws of said State, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of this corporation is QUALLS BROTHERS,

ARTICLE II

The general nature of the business to be transacted by this corporation is:

(a) To Acquire, by purchase, lease, or otherwise, lands and interests in lands, and to own, hold, improve, develop, and manage any real estate so acquired, and to erect, or cause to be erected, on any lands owned, held, or occupied by the corporation, buildings or other structures, with their appurtenances, and to manage, operate, lease, rebuild, enlarge, alter or improve any buildings or other structures, now or hereafter erected on any lands so owned, held, or occupied, and to encumber or dispose of any lands or interests in lands, and any buildings or other structures, and any stores, shops, suites, rooms, or part of any buildings or other structures, at any time owned or held by the corporation.

To acquire, by purchase, lease, manufacture, or otherwise, any personal property deemed necessary or useful in the equipment, furnishing, improvement, development, or management of any property, real or personal, at any time owned, held, or occupied by the corporation and to invest, trade, and deal in any personal property

deemed beneficial to the corporation, and to encumber or dispose of any personal property at any time owned or held by the corporation.

(b) To acquire by purchase, lease, or otherwise, and to improve, and develop real property, To erect dwellings, apartment houses, motels, hotels and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave, and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, and playgrounds. To buy, sell, mortgage, exchange, lease, let, hold for investment or otherwise, use and operate, real estate of all kinds, improved or unimproved, and any right or interest therein.

(c) To buy, sell, and generally deal in household goods, and house furnishings, furniture, carpets, rugs, beds, bedding, blankets, quilts, stoves, lamps, electric lamps and fixtures, radios, clocks, curtains, draperies, portieres, kitchen utensils, vacuum cleaners, electric household appliances of all types, and every other thing that is or may be used in furnishing a house. To acquire, by purchase or otherwise, real estate and plants necessary to conduct such business.

(d) To engage in every aspect and phase of the business of operating a trailer park, and the rental of trailers and trailer lots.

(e) To manufacture, buy, import, or otherwise acquire, and to distribute, export, sell or otherwise dispose of, either by wholesale or retail, lumber, cement, hardware, building materials, and supplies of every kind and character; to establish and maintain sawmills, plants, yards, stores, warehouses, and other manufacturing and distributing centers for the manufacture, assembling, and distributing of any and every kind of commodity, goods, wares, merchandise, or other articles of trade or commerce.

(f) To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares,

merchandise, real and personal property, and ~~services~~, of every class, kind, and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

(g) To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge, or otherwise turn to account, or otherwise dispose of the shares of the capital stock of, or any bonds, securities, or evidence of indebtedness, created by any other corporation of this state or any state or government, and while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote thereon.

(h) To purchase, hold, sell and transfer shares of its own capital stock as lawfully as may be done under the laws of the State of Florida; to borrow money, contract debts when necessary for the transaction of its business, and to issue bonds, promissory notes, bills of exchange, debentures, and other obligations of indebtedness, whether secured by mortgages, pledge or otherwise, or unsecured.

(i) Without in any particular limiting any of the objects, purposes, or powers of the Corporation, the business and purposes of the Corporation shall be, from time to time, to do any one or more, or all, of the acts set forth and any such acts, things or business in any manner connected therewith, or necessary, incidental, convenient or auxiliary thereto, or calculated, directly or indirectly to promote the interests of the Corporation, or enhance the value or render profitable any of its properties or rights.

ARTICLE III

The maximum number of shares of stock which this Corporation shall have outstanding at any one time is:

Six hundred shares of Common Voting Stock
having a nominal or par value of ten dollars
(\$10.00) per share.

All such shares shall be issued, when they are issued,
fully paid and non-assessable. The capital stock of the Corpor-
ation may be paid for in lawful money of the United States, or in
property, labor or services at a fair and just valuation, to be
fixed by the Board of Directors.

ARTICLE IV

The amount of capital with which this corporation shall
begin business is five hundred dollars, (\$500.00).

ARTICLE V

This Corporation shall have perpetual existence.

ARTICLE VI

The street address of the principal office of the Corpor-
ation shall be 230 41st Street Gulf, Marathon, Florida. The
Board of Directors, may from time to time move the principal
office to any other address in Florida.

ARTICLE VII

This Corporation shall have three directors initially.
The number of directors may be increased or diminished from time
to time, by by-laws adopted by the stockholders, but shall never
be less than three.

Either through appropriate provisions of the by-laws,
or by resolution passed by a majority of the whole Board of
Directors, the Board of Directors may designate two or more of
their number to constitute an executive committee, which committee,
to the extent provided in such by-laws or resolution, shall have
and may exercise the powers of the board of directors in the
management of the affairs and property of the corporation and the
exercise of its corporate powers; and if such committee shall

consist of more than two persons, a majority thereof shall be sufficient to exercise all its powers.

ARTICLE X

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholder's meeting by a majority of the stockholders entitled to vote thereon unless all the directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of the Articles of Incorporation be made.

ARTICLE XI
