ARTICLES OF AMENDMENT FILED RIVER CITY AVIATION, ING. 8 SEP 17 AM 9: 24

These Articles of Amendment are filed pursuant to Floridal Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of RIVER CITY AVIATION, INC., and in connection therewith, the undersigned officers, acting upon authority of the Board of Directors of RIVER CITY AVIATION, INC., and upon authority of all of the shareholders of this Corporation, hereby set forth as follows:

- 1. The name of this Corporation is RIVER CITY AVIATION, INC.
- 2. The Articles of Incorporation of RIVER CITY AVIATION, INC. have been amended by inserting the following sentence at the end of Article VII thereof:

"Any vacancy occurring in the Board of Directors, including any vacancy created by reason of an increase in the number of Directors, may only be filled by the affirmative vote of the holders of a majority of the shares entitled to vote thereon."

In accordance with Florida Statute Section 607.1003, the referred to amendment was adopted by the Board of Directors on September 2, 1998, and by the holders of all of the shares entitled to vote thereon on September 2, 1998, in accordance with Florida Statutes Section 607.0704.
