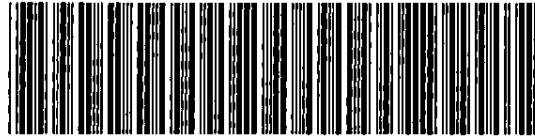

Article II. Address

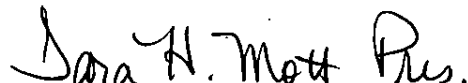
