



 - 2. The Corporation filed Articles of Incorporation on June 5, 1969.
- 3. Dissolution of the Corporation was recommended by the Board of Directors of the Corporation and was unanimously approved by all of the Shareholders and Directors of the Corporation on March 20, 1998 by a Joint Action by Unanimous Written Consent of the Shareholders and Directors of the Corporation (the "Action"), a copy of which is attached hereto as Exhibit "1" and made a part hereof.

JOINT ACTION BY UNANIMOUS WRITTEN CONSENT OF THE SHAREHOLDERS AND DIRECTORS OF MANGUS NURSERY & LANDSCAPING CO INC IN LIEU OF A MEETING

The undersigned, being all of the Shareholders and Directors of Mangus Nursery & Landscaping Co Inc, a Florida corporation (the "Corporation"), hereby adopt the following Resolutions pursuant to Florida Statutes Sections 607.0704, 607.0821, 607.1402 and 607.1403 and pursuant to Section 331 of the Internal Revenue Code of 1986, as amended, which Resolutions are to have the same force and effect as if passed by a unanimous vote of all the Shareholders and Directors of the Corporation at a duly called and convened meeting thereof:

WHEREAS, substantially all of the cash of the Corporation has heretofore been distributed in liquidation to the undersigned Shareholders;

WHEREAS, a truck belonging to the Corporation has heretofore been conveyed to Lloyd H. Mangus for certain consideration, which all of the Directors of the Corporation have heretofore deemed to be adequate;

WHEREAS, the Corporation owns no other assets;

WHEREAS, all of the Shareholders believe it to be in the best interests of the Corporation to wind down and dissolve the Corporation;

WHEREAS, all of the Shareholders desire that the effective date of dissolution be June 30, 1998; and

WHEREAS, all of the Shareholders desire to adopt the Articles of Dissolution for the Corporation (the "Articles of Dissolution") in the form attached as Exhibit "A" and made a part hereof.

NOW THEREFORE, Be It

RESOLVED, that the Corporation shall wind down and be dissolved;

FURTHER RESOLVED, that the effective date of dissolution shall be June 30, 1998;

FURTHER RESOLVED, that the Articles of Dissolution shall be and hereby are approved and adopted; and

FINALLY RESOLVED, that the proper Directors, officers and representatives of the Corporation shall be and hereby are authorized, empowered and directed to take any and all

action necessary, appropriate or desirable in order to implement the foregoing Resolutions including, without limitation, the execution and filing of the Articles of Dissolution.

IN WITNESS WHEREOF, the undersigned, being all of the Shareholders and Directors of the Corporation, have executed this Joint Action by Unanimous Written Consent on this 20 day of March, 1998 for the purposes therein contained.
