ARTICLE I NAME

The name of the corporation is ZIP SLIDES, INC.

ARTICLE II SHARES

The total number shares of stock which the corporation shall have authority to issue is Thirty (30) shares of Common Stock, each with no par value.

ARTICLE III BOARD OF DIRECTORS AND OFFICERS
