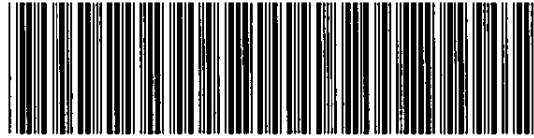

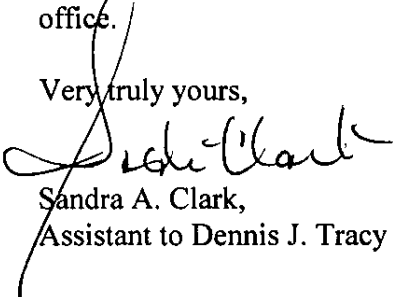

**FIRST:** The name of the corporation is **PARK ISLES, INC.**

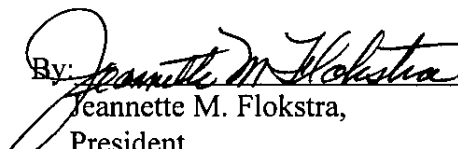
**SECOND:** The dissolution was authorized on November 23, 2007.

**FOURTH:** These Articles of Dissolution will take effect on their filing with the office of the Florida Secretary of State.

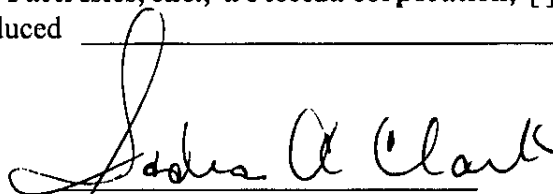
