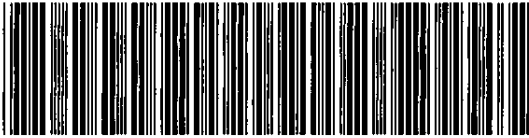

FIRST: The name of the corporation is SPEIR CONSTRUCTION COMPANY.


SECOND: The shareholders of the company approved the dissolution of the company on March 10, 2006.
