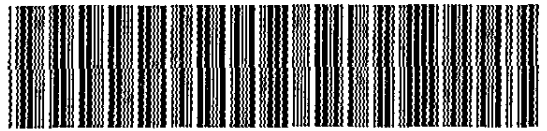

THIRD: Adoption of dissolution was approved by the Shareholders. The number of votes cast for dissolution was sufficient for approval.

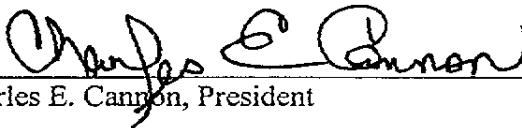
FOURTH: No debt of the corporation remains unpaid.
