## ARTICLES OF AMENDMENT

DURHAM BUILDING MATERIALS, INC.

These Articles of Amendment are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of DURHAM BUILDING MATERIALS, INC., and in connection therewith, the undersigned officers, acting upon authority of the Board of Directors of DURHAM BUILDING MATERIALS, INC., and upon authority of all of the shareholders of DURHAM BUILDING MATERIALS, INC., hereby set forth as follows:

1. The name of this Corporation is DURHAM BUILDING MATERIALS, INC.
2. The Articles of Incorporation of DURHAM BUILDING MATERIALS, INC. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article I:

"ARTICLE I - Name

The name of this Corporation shall be:

"Jacksonville Durham, Inc."

3. In accordance with Florida Statute Section 607.1003, the above Amendment was adopted by the Board of Directors of DURHAM BUILDING MATERIALS, INC. on June 30, 2022, and written consent to this Amendment was given on June 30, 2022, by all the shareholders comprising the only voting group in accordance with Florida Statute Section 607.0704. The number of votes cast for the Amendment by the stockholders is sufficient for approval of the Amendment by all voting groups of DURHAM BUILDING MATERIALS, INC.

4. Upon the filing of these Articles of Amendment by the Department of State, the above Amendment shall become effective and the Articles of Incorporation of DURHAM BUILDING MATERIALS, INC., shall be deemed to be amended accordingly.
