ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PRECISIONAIRE, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Precisionaire, Inc., a Florida corporation, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Precisionaire, Inc.
- 2. Article 7 of the Articles of Incorporation of the corporation is hereby amended in its entirety to read as follows:
 - "7. BOARD OF DIRECTORS. The number of directors of the corporation shall be fixed or changed in accordance with the by-laws of the corporation. Each of the said directors shall be of full age and at least one of them shall be a citizen of the United States. A quorum for the transaction of business shall be a majority of the directors qualified and active, and the act of a majority of the directors present at a meeting at which a quorum is present shall be the act of the directors. Subject to the by-laws of the corporation, meetings of the directors may be held within or without the State of Florida. Directors need not be shareholders. The shareholders of the corporation may remove any director from office at any time with or without cause."
- 3. The date of adoption of the amendment was June 5, 2012.
- 4. This amendment was adopted by the sole shareholder of the corporation. The number of votes cast for the amendment by the sole shareholder was sufficient for approval.
