ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

- 1. The name of the Corporation is R.A.O. ELECTRIC COMPANY.
- 2. Article VII of the Articles of Incorporation of the Corporation is hereby amended in its entirety to provide as follows:

THEREFORE RESOLVED, that Article VII of the Articles of Incorporation of the Corporation is hereby amended in its entirety to provide as follows:

"ARTICLE VII

The Board of Directors shall be not less than one (1) in number. The number of Directors may be increased and, if increased, thereafter decreased to a number of not less than one (1) by the shareholders of this corporation."
