

The undersigned hereby waives notice of any meetings to effect the foregoing Articles of Dissolution and approves and ratifies the action taken above.

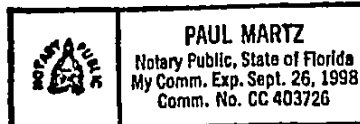
