As I mentioned to you on the telephone last week, Independent Fire Insurance Company of Florida is preparing to change its name to American General Property Insurance Company of Florida by amending its articles of incorporation. The Florida Department of Insurance approved the articles of amendment on May 5, 1997 and we are ready to file the approved articles of amendment with the Florida Secretary of State. I do not have a specific deadline to file the amendment but perhaps Monday, June 2, 1997, would be a good date.

Enclosed are two original copies, stamped approved, of the Articles of Amendment to The Articles of Incorporation of Independent Fire Insurance Company of Florida. Please file one copy of this document with the Florida Secretary of State and have the other copy stamped as received or however the extra copy should be stamped.
