**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of **TURBANA CORPORATION**, a Florida for profit corporation (the "*Corporation*"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Turbana Corporation.

SECOND: The Articles of Incorporation of the Corporation are hereby amended by deleting Article I thereof as it now exists and inserting in lieu thereof the following new Article I, reading as follows:

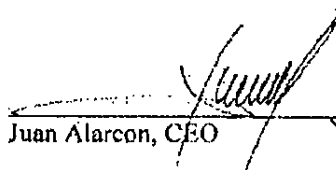
"ARTICLE I
Name and Principal Office of the Corporation

The name of the Corporation is Fyffes North America Inc. The principal office of the Corporation is located at 999 Ponce De Leon Boulevard, Suite 900, Coral Gables, FL 33134."

THIRD: The effective date is the date these Articles of Amendment are approved by the Florida Secretary of State.
