OF
HECTOR HEATING AND AIR CONDITIONING, INC.

The undersigned subscribers to these articles, each a natural person competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be Hector Heating and Air Conditioning, Inc.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in the business of installing and repairing heating and air conditioning units and appliances in residential and commercial buildings, and to engage in any businesses incidental or related thereto, and to do all things necessary or incidental to the proper conduct of such business, including but not limited to the following:

To provide services of every kind or character related or incidental to the business described herein; and to build, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property,

and services, of every kind, class and description except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone, or cemetery company, or a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, or a state fair or exposition;

To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida, and in all other states and countries;

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebtedness as required;

To purchase the corporate assets of any other corporation and engage in the same or other character of business;

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida, or any other state or government, and while owner of such stock, to exercise all the rights, powers, and privileges of ownership including the right to vote such stock;

The foregoing enumeration of specific purposes and powers shall not be deemed to limit or restrict in any manner the general powers of the corporation, and the enjoyment and exercise thereof, as conferred by the laws of the State of Florida, upon corporations under the provisions of its law.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Ten Thousand shares of common stock, having the nominal par value of One and no/100 (\$1.00) Dollar per share.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is One Thousand and no/100 (\$1,000.00) Dollars.

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. ADDRESS

The initial address of the principal office of this corporation in the State of Florida is Route 1, Box 387R, Cantonment, Florida. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VII. DIRECTORS

This corporation shall have three directors, initially. The number of directors may be increased or diminished from time to time by by-laws adopted by the Board of Directors and approved by the stockholders, but shall never be less than three.

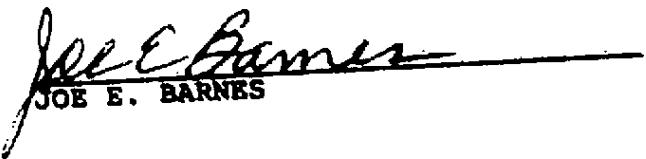

ARTICLE X. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a two-thirds (2/3) majority of the stock entitled to vote thereon.

ARTICLE XI. RESTRICTIONS ON SALE OF STOCK

In case a stockholder, his personal representatives, heirs, devisees, legatees, pledgee, assignee, receiver, trustee in bankruptcy, or any other person holding under or in privity with any stockholder, desires to sell his shares of stock, he must first offer them for sale to the remaining stockholders and to the corporation, it being the intention hereby to give the remaining stockholders and the corporation a preference in the purchase of such shares of stock, and any attempted sale in violation of this provision shall be null and void. The stockholder, his personal representative, heir, devisee, legatee, pledgee, assignee, receiver, trustee in bankruptcy or any other person holding under or in privity to any stockholder, desiring to sell his stock, shall file notice in writing of such intention with the Secretary of the corporation stating the terms of the sale, and unless his terms are accepted by any or all of the stockholders or by the corporation within twenty days thereafter, such stockholders and the corporation shall be deemed to have waived their privilege of purchasing and the stockholder or the person in privity with him desiring to sell shall be at liberty to effect a sale to any one who will accept such terms.
