## ARTICLES OF INCORPORATION OF

## **GULF STATE BANK**

The undersigned officers of GULF STATE BANK of Carrabelle, Florida do hereby certify that the Board of Directors of said financial institution approved and proposed to the shareholders thereof, amendment to Article 1 of the Articles of Incorporation as set out herein, and that thereafter on the 11<sup>th</sup> day of February, A.D. 1998, at a special meeting of the shareholders called and held in compliance with Section 607.1006, Florida Statutes, and with the Articles of Incorporation and bylaws of said corporation at its office in Carrabelle, Florida, at which meeting the holders of a majority of the outstanding capital stock were present.
