
Unfortunately, the first notice we had that an annual return had not been filed with the annual fee was the Notice of Administrative Dissolution or Revocation.

We absolutely did not receive this year's annual report and I can only guess that it was due to the postal office's failure to forward certain mail items. We are no longer at 3438 Lawton Road, Suite 200, but have moved to 3113 Lawton Road, Suite 225, Orlando, FL 32803. It would seem odd that they forwarded the Notice of Administrative Dissolution (no indication it was forwarded on the face of it, however), yet did not forward the Annual Report. It is quite possible that a person at our old address threw out the annual report when it was mailed, and that someone else chose to deliver the notice to us since we were co-tenants for so many years with their offices in the 3438 building.

If at all possible, we would simply like to file this year's report and pay the standard fee in lieu of the extremely high reinstatement fee. We have had only minor problems with mail forwarding and it never occurred to us to change the address for this corporation with the Secretary of State.
