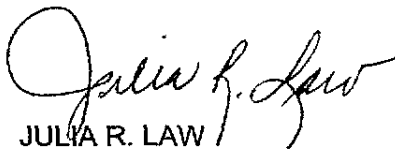

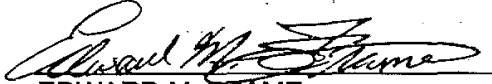
ARTICLE I

The amendment was approved by the board of directors and shareholders on June 18, 2004.

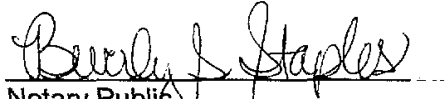
