I, the undersigned, being of full age, do hereby associate myself together and do hereby agree for myself, my associates and assigns, to become a corporation for profit under the provisions of Chapter 608, Florida Statutes, and do hereby accept all the rights, privileges, benefits and obligations conferred and imposed by said law on corporations organized pursuant to the provisions thereof, and hereby make, subscribe, certify, acknowledge and file the Articles of Incorporation as follows:

ARTICLE I

The name of this corporation shall be TURNER DEVELOPMENT, INC.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the United States and of this State, and shall have the power to conduct its business within the State of Florida, throughout the United States and in all foreign countries.

No contract or other transaction between the corporation and any other person, firm, association or corporation shall be affected or invalidated by the fact that any one or more of the directors, officers or shareholders, of this corporation is or are interested in, or is a director, shareholder, or officer, or are directors, shareholders, or officers, of such other firm, association, or corporation, or in any manner related to or associated with any such person, and any director or directors, shareholder, or shareholders, or officer or officers, individually or jointly may be a party of parties to, or may be interested in any contract or transaction of this corporation, or in which this corporation

is interested, and no contract, act or transaction of this corporation with any person or persons, firms, associations, or corporations shall be affected or invalidated by the fact that any director or directors, shareholder or shareholders, officer or officers of this corporation is a party, or are parties to or interested in such contract, act or transaction, or in any way connected with such person or persons, firms or associations or corporations, and each and every person or persons, firms or associations, and each and every person who may become a director of this corporation is hereby relieved from any liability that might otherwise exist from contracting with the corporation for the benefit of himself or any firm or corporation in which he may be in anywise interested.

ARTICLE III

The amount of capital stock authorized shall be TEN THOUSAND (\$10,000) DOLLARS divided into ONE THOUSAND SHARES (1,000) of TEN (\$10) DOLLAR par value stock to be held, sold and paid for at such time and in such manner as the Stockholder may from time to time determine. All of the capital stock shall be common stock.

ARTICLE IV

The corporation shall continue perpetually unless sooner dissolved according to law.

ARTICLE V

The corporation shall begin business with capital of not less than FIVE HUNDRED (\$500) DOLLARS.

ARTICLE VI

The initial place for the transaction of its business shall be in the City of Arcadia, County of DeSoto, and State of Florida, at 15 North Brevard Avenue.

ARTICLE VII

The Incorporator and Stockholder agrees that this corporation shall be managed by the Stockholder of the corporation and not by a Board of Directors.

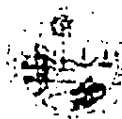
