The undersigned corporation organized and existing under and by virtue of the Florida Business Corporation Act,

DOES HEREBY CERTIFY:

1. That the name of the corporation is First of Eustis, Inc.
2. That by action by written consent of the sole shareholder of First of Eustis, Inc. dated as of April 13, 1998, one amendment to the Articles of Incorporation, as previously amended, of the corporation was duly adopted by the shareholder. The amendment is to Article I of the Articles of Incorporation and changes the name of the corporation from First of Eustis, Inc. to Colonial Investment Services of Florida, Inc. so that Article I now is as follows:

**ARTICLE I – NAME OF CORPORATION**

The name of this corporation shall be COLONIAL INVESTMENT SERVICES OF FLORIDA, INC.
