ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PRE-CAST SPECIALTIES, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of PRE-CAST SPECIALTIES, INC. (the "Corporation") are hereby amended according to theses Articles of Amendment:

FIRST: The name of the Corporation is PRE-CAST SPECIALTIES, INC.

SECOND: Article I of the Articles of Incorporation, as amended, is hereby deleted in its entirety and the following inserted in lieu thereof:

"The name of the Corporation is PRE-CAST SPECIALTIES HOLDING, INC."

THIRD: Article III of the Articles of Incorporation, as amended, is hereby deleted in its entirety and the following inserted in lieu thereof:

"The Corporation shall be authorized to issue 1,000 shares, consisting of 500 voting common shares, with a par value of One (\$1.00) Dollar per share and 500 nonvoting common shares, with a par value of One (\$1.00) Dollar per share. Each class of shares shall be identical in all respects, except that the nonvoting shares shall carry no right to vote for the election of directors of the Corporation, and no right to vote on any matter presented to the shareholders for their vote or approval except only as the laws of the State of Florida require that voting rights be granted to such nonvoting shares."

FIFTH: Except as hereby amended, the existing Articles of Incorporation of the Corporation shall remain in full force and effect.
