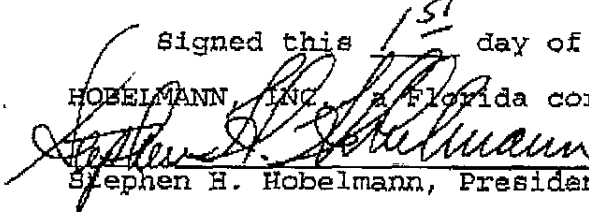
ARTICLES OF DISSOLUTIONOFHOBELMANN, INC.

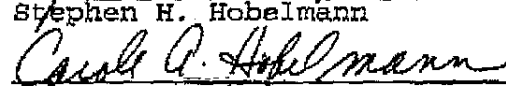
UNANIMOUS WRITTEN CONSENT

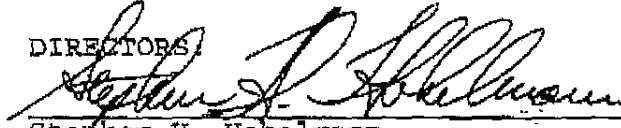

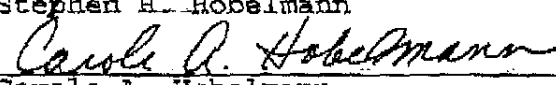
