Pursuant to the provisions of Section 607.1003 of the Florida Statutes, the undersigned Resident and Secretary of DATA FINANCIAL, INC., a corporation existing under the laws of the State of Florida, does hereby certify:

- (a) The name of this Corporation is DATA FINANCIAL, INC.
- (b) The amendment adopted is an amendment to Article III of the Articles of Incorporation of this Corporation increasing the authorized number of shares. The said amendment reads as follows:

#### "ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to have outstanding is One Thousand (1,000) shares of common stock, each with a par value of \$5.00 per share.
