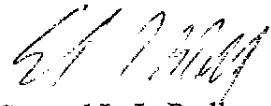

Pursuant to the provisions of Section 607.1003 of the Florida Statutes, the undersigned

President and Secretary of DATA FINANCIAL, INC., a corporation existing under the laws of the State of Florida, does hereby certify:

- (a) The name of this Corporation is DATA FINANCIAL, INC.
- (b) The amendment adopted is an amendment to Article III of the Articles of Incorporation of this Corporation increasing the authorized number of shares. The said amendment reads as follows:

"ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to have outstanding is One Thousand (1,000) shares of common stock, each with a par value of \$5.00 per share. All of said stock shall be payable in cash, property, labor or services at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose; and any and all such shares so issued, the full consideration for which has been paid or delivered shall be deemed fully paid stock and not liable to any further call or assessments thereof, and the holder of such shares shall not be liable for any further payment thereon."

- (c) This amendment was adopted by unanimous consent of the Directors of this Corporation and by the sole Shareholder of this Corporation effective as of the 1st day of July, 1999. This number of votes cast for the amendment by the Shareholders was sufficient for its approval.
