Per telephone instructions from Markita and Kathy, FL Dept. of State, at (850) 245-6059, enclosed please find executed Reinstatement Form, along with our Check #1397 in the amount of \$300.00 (for the years 2003 and 2004), to put our corporation back into Active Status. We were also advised that since this only pertains to a "mailing address correction", the registered agent's signature is not required on this form. Below is an explanation of what appears to have happened:

I recently realized that we had not received our Annual Report Form for 2004. I went on the internet, printed a copy of our company's status and noticed that our company is currently in "inactive" status as of 9/19/03. I also noticed that the Principal Address and Mailing Address listed were incorrect. Our address is NOT "68th" Street. Our correct address is "88th" Street. It appears there was a typographical error.

It also appears that our 2003 Annual Report Form was sent to the incorrect address without us having any knowledge of same until now; therefore, we never filed a report for 2003, as we depend on receiving the form/notice each year from the Department of State in order to file same. If you check our past history, you will notice that we have consistently filed an Annual Report each year.
