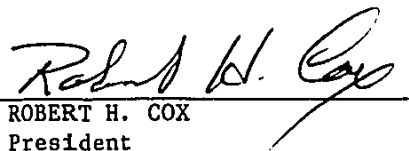

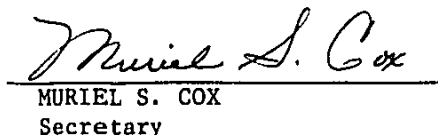
Article I of the Articles of Incorporation of S & R Engineering, Inc. is amended to read as follows:

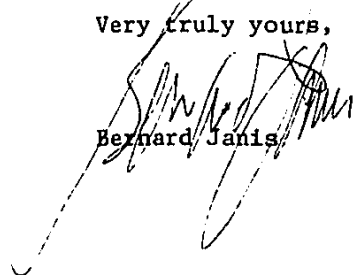
