DENTON ADVERTISING, INC., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation, in accordance with the requirements of Chapter 607, Florida Statutes, hereby certifies as follows:

- 1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on May 3, 1971, at which time the name of the Corporation was "Gray & Denton, Inc.".
- 2. The Amendment to the existing Articles of Incorporation being effected hereby is that resulting from completely deleting Article I of the Articles of Incorporation as of the date hereof, and by substituting in its place the Article set forth below.
