Attached please find the Corporation Reinstatement and a check for \$600 for the above referenced corporation. We are asking that the Reinstatement fee/penalty of \$600 be waived due to the following:

- This corporation is one of three family owned businesses that leased/used 2105 Tyrone Blvd, St. Petersburg, FL 33710 as it's corporate mailing address. The main business at 2105 Tyrone Blvd operated by the Patriarch was closed May 1998. The Patriarch's business leased 2105 Tyrone Blvd, and typically had handled all state and federal filings. The Patriarch retired May 1998 and vacated 2105 Tyrone Blvd. Subsequently, the office space at 2105 Tyrone Blvd was leased to another party.
- The subsequent tenant was kind enough to accept mail on behalf of the former tenant through January 31, 1999. Accordingly, the 1999 Annual Report was filed on time. However, the change of address was inadvertently overlooked. Any mailings received at 2105 Tyrone Blvd after January 31, 1999 would not have been accepted by the current tenant, or deemed undeliverable by the US Postal Service.
- The 2000 Annual Report and any further notification from the Department of State would have been undeliverable.
