- This corporation is one of three family owned businesses that leased/used 2105 Tyrone Blvd, St. Petersburg, FL 33710 as it's corporate mailing address. The main business at 2105 Tyrone Blvd operated by the Patriarch was closed May 1998. The Patriarch's business leased 2105 Tyrone Blvd, and typically had handled all state and federal filings.
