Pursuant to the provisions of Section 607.1006, Florida Statutes, The Goldfield Consolidated Mines Company, a Florida profit corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The amendments to the Articles of Incorporation of the Corporation are as follows:

A. That Article I of the Articles of Incorporation of the Corporation be and is hereby deleted in its entirety and the following new Article I be and is hereby substituted in lieu thereof:

"I. The name of the corporation shall be: AGGCO Mining Company."

B. That, as so amended, the original Articles of Incorporation, together with this amendment, shall constitute the Article of Incorporation of the Corporation.

SECOND: The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
