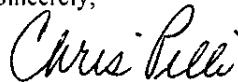

RESTATED ARTICLES OF INCORPORATION OF BIGHAM HIDE COMPANY, INC.

In compliance with Chapter 607 and Chapter 607.1006, F.S. (Profit), Bigham Company, Inc. restates their Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: Bigham Hide Company, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business is: US 301 South, Coleman, Florida 33521

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any lawful business or activity permitted under the laws of the State of Florida.

ARTICLE IV - SHARES

Article IV of the Articles of Incorporation shall be amended to read, in its entirety, as follows:

The maximum shares of stock of the Corporation that may be issued is Fifteen Thousand (15,000) shares consisting of One Thousand Five Hundred (1,500) voting shares with One Dollar (\$1.00) par value and Thirteen Thousand Five Hundred (13,500) non-voting shares with One Dollar (\$1.00) par value.

The amendment was adopted by the Shareholders on November 26, 2007 and the number of votes cast for the amendment was sufficient for approval.

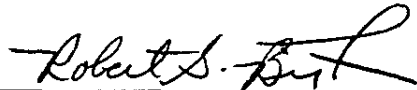
