The undersigned corporations, having adopted a Plan and Agreement of Merger, hereby adopt these articles of merger and submit these Articles of Merger in accordance with the *Fla. Stat.* § 607.1105.. The name of the surviving corporation is KREIDER LAUNDRY LEASING COMPANY, a Florida corporation, authorized to do business in the State of Florida. The name of the disappearing and/or merging corporation is KREIDER RACING, INC., a Florida corporation.

Approval by Directors

The Plan and Agreement of Merger of the undersigned corporations was adopted pursuant to Section 607.1103 of the Florida Business Corporation Act and the same shall be applicable to the surviving corporation and the disappearing and/or merging corporation. Pursuant to Section 607.1103(7), Shareholder approval was not required .

Effective Date

The merger of the undersigned corporations was approved in accordance with the Plan and Agreement of Merger. In accordance with Florida Statute 607.1105, the effective date of the merger shall be on December 31, 2003.

Articles of Incorporation

No changes in the Articles of Incorporation of the surviving corporation have been made.

Plan of Exchange

The sole director of KREIDER LAUNDRY LEASING COMPANY, and KREIDER RACING, INC. adopted the Plan and Agreement of Merger on the 5th day of December, 2003. The Plan and Agreement of Merger provides for KREIDER RACING, INC. to transfer to KREIDER LAUNDRY LEASING COMPANY all of the assets of KREIDER RACING, INC. subject to all of its liabilities and obligations, and complete cancellation of all of the capital stock of KREIDER RACING, INC. The certificate representing the shares of stock of the disappearing and/or merging corporation shall be surrendered and canceled on the date as set forth above.

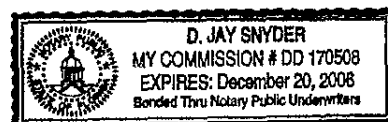


