Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, **Tampa Reading Clinic & Day School, Inc.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Tampa Reading Clinic and Day School, Inc.
2. The following Amendment to the Articles of Incorporation (the "Amendment") was adopted on August 15<sup>th</sup>, 1997, by the sole director and sole shareholder of the Corporation in strict compliance with the provisions of Section 607.1003 of the Florida Business Corporation Act:
