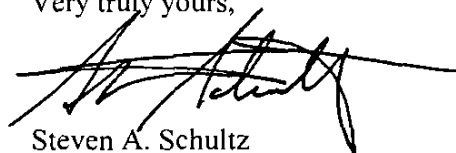

When I spoke with one of your representatives last week, I was informed that the original name of this corporation (i.e. "Equity International Corporation") was no longer available and therefore I am including herewith the "Articles of Amendment".

We request that you waive the \$600.00 penalty for reinstatement on grounds that the address of this corporation was not correctly shown in your records and apparently your previous mailings went to the wrong address. Please note that the address you show in your records is "7451 N.W. 63rd Street", Miami, Florida". However the actual address of the corporation, as shown in the enclosed reinstatement form is "7475 N.W. 63rd Street", Miami, Florida. Based on this address problem and the failure of my client to receive the appropriate notification as to dissolution, etc from the Department, I request that the corporation be reinstated without the imposition of the subject penalty.
