ARTICLE SECOND: The Amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE I of the current Articles of Incorporation, as amended, is further amended to provide as follows:

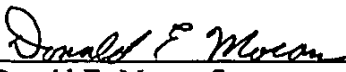
ARTICLE I - NAME
