The effective date of the dissolution of the corporation shall be November 22, 1999.

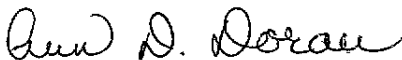

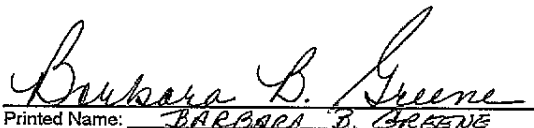
