



The name of this Corporation shall be RON T. ENTERPRISES, INC.



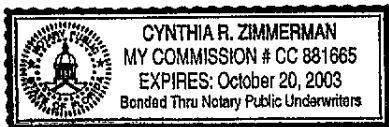


