

The undersigned, certifies that:

- 1. He is the President of ABEL, BAND, RUSSELL, COLLIER, PITCHFORD & GORDON, CHARTERED, a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on July 7, 1972, as amended.
- 2.
