

Pursuant to the requirements of Sections 607.1001, 607.1003 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of **CHARPIT**, **INC.**, (the "Company"), which Company was incorporated under the laws of the State of Florida on July 19, 1972:

1.
