FIRST:

The name of the Corporation is LAFARGE FLORIDA INC.

SECOND: The Articles of Incorporation of this Corporation are amended by changing Article I so that, as amended, said Article shall read as follows:

ARTICLE I

The name of the Corporation is I'LORIDA CEMENT, INC.

TTHEO: The Articles of Incorporation of this Corporation are amended by changing Article VI so that, as amended, said Article shall read as follows:

ARTICLE VI
