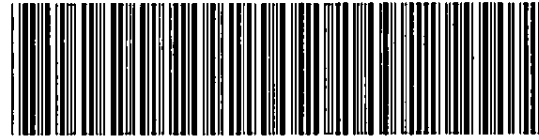

ARTICLES OF INCORPORATION

OF

REINFORCING STEEL SERVICE OF FLORIDA, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is:

ARTICLE II

NATURE OF BUSINESS

The general character or nature of the business to be transacted by this corporation is:

(a) To provide steel and iron erection services and related construction services.

(b) To acquire by purchase, lease, or otherwise, lands and interests in lands, and to own, hold, improve, develop and manage any real estate so acquired, and to erect, or cause to be erected, on any lands owned, held, or occupied by the corporation, buildings or other structures, public or private, with their appurtenances, and to manage, operate, lease, rent, rebuild, enlarge, alter, or improve any buildings or other structures, now or hereafter erected on any lands or interests in lands, and any buildings or other structures, at any time owned or hold by the corporation. To buy, sell, mortgage, exchange, lease, hold for investment or otherwise, use and operate, real estate of all kinds, improved or unimproved, and any right or interest therein.

(c) To acquire, by purchase, lease, manufacture, or otherwise any personal property deemed necessary or useful in the equipment, furnishing, improvement, development or management of any property, real or personal, at any time owned, held, or occupied by the corporation, and to invest, trade, and deal in any personal property deemed beneficial to the corporation, and to lease, rent, encumber or dispose of any personal property at any time owned or held by the corporation.

(d) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

(e) To purchase the corporate assets of any other corporation and engage in the same or other character of business.

(f) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

(g) To enter into, make, perform, and carry out contracts and agreements of every kind, for any lawful purpose, without limit as to amount, with any person, firm, association, or corporation; and to transact any further and other business necessarily connected with the purposes of this corporation, or calculated to facilitate the same.

(h) To carry on any or all of its operations and businesses, and to promote its objects within the State of Florida or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all of the general powers of like corporations.

(i) To engage in any and all lawful businesses, trades, occupations and professions.

(j) To do any or all of the things herein set forth to the same extent as natural persons might or could do, and in any part of the world as principals, agents, contractors, or otherwise, along, or in the company with others, and to do and perform all such other things and acts as may be necessary, profitable, or expedient in carrying on any of the business or acts above-named.

The intention is that none of the objects and powers as hereinabove set forth, except where otherwise specified in this Article, shall be in anywise limited or restricted by reference to or inference from the terms of any other objects, powers or clauses of this Article or any other Articles; but that the objects and powers specified in each of the clauses in this Article shall be regarded as independent objects and powers, and in addition to the powers afforded Florida corporation by law.

### ARTICLE III

#### CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is five thousand (5,000) shares of common stock, each share having the par value of one (\$1.00) dollar.

Authorized capital stock may be paid for in cash, services, or property, at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.

### ARTICLE IV

#### INITIAL CAPITAL

The amount of the capital with which this corporation shall begin business is five hundred dollars (\$500.00).

ARTICLE V

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VI

The initial street address of the principal office of this corporation is to be at 101 E. Kennedy Blvd., Tampa, Florida.

The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.

ARTICLE VII

DIRECTORS

The Corporation shall be governed by a Board of no less than one nor more than five directors. The number of directors herein provided for may be increased or decreased within these limits at any regular or special meeting of the stockholders. It shall not be necessary for the directors to be stockholders.

ARTICLE VIII

INITIAL DIRECTORS

STOCK RESTRICTIONS

The stockholders may enter into and adopt by agreement, By-Laws or otherwise, limitations upon the transferability or assignment of stock conferring preemptive rights of purchase upon stockholders, as conditions precedent to the sale of stock, provided that reference to any such limitation on transferability shall be noted on the face of the stock certificates of the corporation.


ARTICLE XI  
AMENDMENT

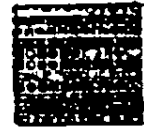



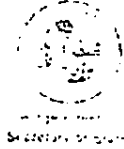

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF COPELAND STEEL ERECTORS, INC.

Pursuant to the provisions of sections 607.177 and 607.187 of the Florida Statutes, Copeland Steel Erectors, Inc. hereby adopts the following Articles of Amendment to its Articles of Incorporation:

(1) Article III of the Articles of Incorporation of Copeland Steel Erectors, Inc. is hereby amended to read as follows:

ARTICLE III  
CAPITAL STOCK

"This corporation is authorized to issue two classes of shares of stock to be designated as "preferred" and "common", respectively; the total number of shares that may be issued by this corporation is 5,100 shares with a par value of \$1.00 per share, one hundred (100) shares to be preferred shares and five-thousand (5,000) shares to be common shares. All or any part of the shares of the common and preferred capital stock may be issued by the corporation from time to time and for such consideration as may be determined and fixed by the board of directors, as provided by law; and when such consideration has been received by the corporation, such shares shall be deemed fully paid.

The nature and extent of the preferences, rights, privileges, and restrictions granted to or imposed upon the holders of the respective classes of stock are as follows:

(a) The holder(s) of the preferred and common stock of the corporation shall each be entitled to one vote per share at the meetings of all shareholders, such voting rights being identical and equal.

(b) In the event of liquidation or dissolution or winding up (whether voluntary or involuntary) of the corporation, the holder(s) of the preferred stock shall be entitled to be paid, in cash, for each share thereof, an amount equal to the value of such shares as set forth in the Shareholders Agreement then in force between the corporation and the shareholders, or, if no such agreement is currently in force, then the value set forth in the previous Shareholders Agreement, before any amount shall be paid to holders of the common stock; and, after such payment, the remaining assets and funds shall be divided and paid to the holders of the common stock pro rata according to their respective shares. In the event that the assets of the corporation are insufficient to permit full payment to the preferred shareholders as herein provided, then such assets shall be distributed ratably among the outstanding preferred shares.

(c) Every holder of preferred stock shall be entitled, at any time, to surrender any or all of his shares of preferred stock to the corporation and to have those share(s) converted into 16.19356 shares of common stock for every share of preferred stock so surrendered. The certificates evidencing those shares of preferred stock exchanged and converted into common stock shall be cancelled and such stock shall then become authorized but unissued and new certificates for the preferred stock not surrendered and converted, and certificates for the appropriate number of shares of common stock to which the shareholder is entitled, shall be issued. The preferred stockholder shall exercise his or her conversion rights by surrendering the necessary certificates for preferred stock to the corporation or its duly appointed agent, along with a written statement setting

forth the number of preferred shares which the shareholder wishes to convert. The appropriate officers of this corporation are hereby directed and authorized to complete the conversion and issuance of such stock within fourteen (14) days of such a surrender.

The corporation shall at all times reserve and keep available, solely for the purpose of conversion of its preferred shares, a sufficient number of authorized but unissued common shares to effect the conversion of all preferred shares outstanding, and the corporation shall obtain and keep in force such permits as may be required to enable the corporation lawfully to issue and deliver such number of common shares. On conversion, no fractional common share shall be issued, but in lieu thereof the corporation shall pay cash at the par value of the fractional common share which would have been issued on such conversion.

Should any increase or reduction in the number of outstanding shares of common stock occur after the date of the issuance of preferred stock by reason of any split, stock dividend, merger, consolidation, or other capital change or reorganization effecting the number of outstanding common shares, the number of common shares to be issued to the holder of the preferred shares upon conversion must be fairly and equitably adjusted by appropriate amendment to this Article so as to fairly and equitably preserve, as far as reasonably possible, the original conversion rights of the shares.

(d) Every holder of preferred stock shall be entitled at any time to demand redemption of all, or any part, of his or her shares of preferred stock in the corporation, the corporation

hereby obligating itself to purchase such shares for cash in the amount set forth in subparagraph (b) above. Such demand shall be made in writing, and delivered or sent to the corporation by registered or certified mail. The corporation shall have thirty (30) days after the receipt of such demand in which to pay for the shares being redeemed, and upon such payment all of the shareholder's rights under those shares shall terminate. The demand notice given by the shareholder shall set forth the class and number of shares to be redeemed by the corporation. The shares redeemed shall be returned to the corporation and be considered authorized but unissued stock. On the date of payment for such redeemed shares, the shareholder shall surrender his or her certificate(s) for such shares to the corporation at the corporate office, and if less than all of the shares represented by any such surrendered certificate(s) are redeemed, a new certificate shall be issued representing the unredeemed preferred shares. The redemption payments may be made from any legally available source of funds."

The exchange of preferred shares for common shares shall be as follows:

All 502 shares of common stock of the corporation owned prior to the adoption of the resolution authorizing the issuance of preferred stock, shall be converted into, and exchanged for, a block of shares of the one dollar (\$1.00) par value preferred stock of this corporation, using a ratio of one share of common stock for .00617529 shares of preferred stock of this corporation. The appropriate officers of this corporation are hereby directed and authorized to complete the exchange and issuance of such stock. For example, a stockholder holding five

hundred and two (502) shares of one dollar (\$1.00) par value common stock of this corporation, owned prior to the adoption of the resolution authorizing the issuance of preferred stock, shall be entitled to thirty-one (31) shares of one dollar par value preferred stock of this corporation. Each such shareholder shall surrender his stock certificates for common stock to the corporation or its duly appointed agent, and, upon receipt of such share certificates, the corporation shall issue and exchange therefore, certificates for shares of preferred stock in the corporation, representing the number of shares of such stock to which such holder is entitled as provided above.

(2) The Articles of Incorporation of Copeland Steel Erectors, Inc. are hereby amended to add the following article:

ARTICLE XIII  
SHAREHOLDER QUORUM AND VOTING

The presence, at any stockholders meeting, in person or by proxy, of persons entitled to vote seventy percent (70%) of the voting stock of the corporation then issued and outstanding, shall constitute a quorum for the transaction of business. The affirmative vote of seventy percent (70%) of all of the voting stock of the corporation, then issued and outstanding, at a meeting at which a quorum is present, shall be the act of the shareholders.

(3) The foregoing amendments to the Articles of Incorporation of Copeland Steel Erectors, Inc. were adopted by the unanimous written consent of the shareholders and directors of the corporation on the 26th day of February 1988, in the manner prescribed by the Florida General Corporations Act, and specifically Florida Statutes Section 607.181(3).
