## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF C. WILSON RANCH, INC. a Florida Corporation

Pursuant to the provisions of Florida Statutes Section 607.1006, this Florida Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:

The document number for this entity is 415210.

**SECOND:** 

The following amendment and restatement of Article III of the Articles ò

was adopted by the Corporation:

### "ARTICLE III

#### CAPITAL STOCK

This corporation shall be authorized to have two classes of common stock, Class A and Class B. Class A common stock shall be voting common stock and each share shall have a par value of One Cent (\$.01). The corporation is authorized to issue up to One Thousand (1,00.00) shares of Class A common stock. Class B common stock shall be non-voting common stock and each share shall have a par value of One Cent (\$.01). The corporation is authorized to issue up to One Hundred Thousand (100,000.00) shares of Class B common stock. Except for the voting rights of the Class A shares of common stock, shares of Class A stock and Class B stock shall be identical with respect to all rights and privileges of such shares, including, without limitation, value, economic rights, distribution rights and liquidation rights.

In conjunction with this recapitalization, each share of currently issued and outstanding common stock of the corporation will be exchanged for one (1) share of Class B common stock except that a single share of the currently issued and outstanding common stock owned by Thomas Richard Wilson shall be exchanged for a single share of the Class A common stock. Following such an exchange, all of the shares of the currently issued common stock shall be cancelled. Following the effective date of these Articles of Amendment to the Articles of Incorporation, the corporation's currently issued and outstanding common stock shall have no value or rights except the right to exchange one share of such stock for one (1) share of the authorized Class B common stock except for the single share of Class A common stock to be issued to Thomas Richard Wilson as set forth above."

THIRD:

The Articles of Amendment were adopted on March 21, 2009. These Articles of Amendment will be effective on and as of the date filed with the Florida Secretary of

State.

FOURTH:

The forgoing amendment was approved by the shareholders. The number of votes cast for these amendments was sufficient for approval.
