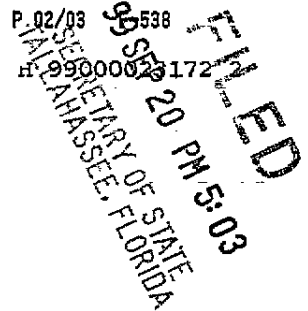

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF

THIRD: This Amendment was unanimously approved by all of the Stockholders and Directors of the Corporation on September 10, 1999.


FOURTH: This Amendment shall be effective upon filing with the Department of State.
