**RESTATED**  
**ARTICLES OF INCORPORATION**  
**OF**  
**RAYMOND BUILDING SUPPLY CORPORATION**  
**FORMERLY KNOWN AS SOUTHWEST FLORIDA SUPPLY CORPORATION**

The undersigned being the sole director and stockholder of RAYMOND BUILDING SUPPLY CORPORATION, pursuant to Section 85.1067, Florida Statutes, hereby restates its Articles of Incorporation and Amendment thereto, as follows:

**ARTICLE I**

The name of the corporation shall be RAYMOND BUILDING SUPPLY CORPORATION.

**ARTICLE II**

This corporation may engage in the building supply business and in any other activity or business permitted under the laws of the United States and of this State.

**ARTICLE III**

The amount of the capital stock of this corporation shall be 100,000 shares of 10¢ par value stock, which said stock shall be non-assessable to be held, sold and paid for at such time and in such manner as the Board of Directors may from time to time determine. All of the capital stock shall be common stock.

**ARTICLE IV**

The amount of capital with which this corporation will begin is ONE THOUSAND AND NO/100 (\$1,000.00) DOLLARS.

The corporation shall commence business as soon as the Secretary of State of Florida approves and issues a Charter, and shall continue perpetually thereafter until sooner dissolved by law.

ARTICLE VI

ARTICLE VII

The corporation shall have a Board of one (1) director and may be increased to not more than five (5) directors. The number of directors each year may be determined by the Stockholder at his annual meeting, or may be fixed by the By-Laws.

ARTICLE VIII

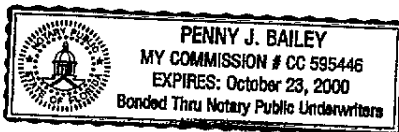

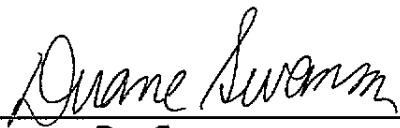

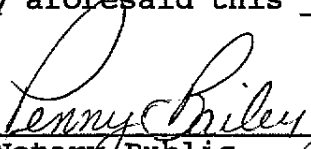
