We recently received a letter from you (# 095A00023784) stating that the check we submitted to you in the amount of \$200.00 could not be processed because we had not filed an annual return.

The annual report that this check was for was included in the envelope with the check. There may have been some confusion because the company name on the annual report was actually Kenco Industrial Equipment, Inc. and not N.B. Handy Company, Inc. We purchased Kenco in June of 1994, however, the name on the annual report was that of Kenco before the acquisition occurred. I telephoned the amendment department in Florida to find out what actions should be taken to change the name.
