ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

SECRETARY OF STATE

THE BANK OF TAMPA

THE BANK OF TAMPA, a banking corporation organized and existing under the laws of State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapters 607, 658, and 660, Florida Statutes, does hereby certify as follows:

- 1. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on March 21, 1973, and have been subsequently amended from time to time.
- 2. Article II of the Articles of Incorporation provides that the Corporation shall engage in the general banking business.
- 3. The amendment to the Articles of Incorporation being effected hereby will completely delete Article II of the Articles of Incorporation as of the date hereof and substitute in its place the Article II set forth below.
- 4. As amended below, Article II of the Articles of Incorporation has the effect of authorizing the Corporation, in addition to engaging in the general banking business, to engage in the general trust business and to exercise trust powers pursuant to Florida law.
- 5. This amendment to the Articles of Incorporation was approved by the board of directors of the Corporation on the 19th day of ______, 2000, and recommended to the shareholders for approval.
- 6. This amendment to the Articles of Incorporation was approved by the shareholders on the 19th day of January, 2000, and the number of votes cast for the amendment by the shareholders was sufficient for approval.

These Articles of Amendment to the Articles of Incorporation shall be effective 7. immediately upon filing by the Secretary of State of the State of Florida and, thereafter, Article II of the Articles of Incorporation of the Corporation shall read as follows:

ARTICLE II

The general nature of the business to be transacted by this corporation shall be: That of a general banking and trust business with all the rights, powers and privileges granted and conferred by the banking and trust business laws of the State of Florida, regulating the organization, powers and management of banking corporations with trust powers.

IN WITNESS WHEREOF, THE BANK OF TAMPA has caused these Articles of Amendment to the Articles of Incorporation to be executed this 19thday of January 2000.
