Pursuant to Sections 607.0704, 607.0821, 607.1003 and 607.1006, Florida Statutes, the undersigned, constituting all of the Directors and Stockholders of ASSOCIATED COMPANIES, INC., hereby adopt the following amendment to the Articles of Incorporation.

Article III is hereby deleted and the following new Article III is added in lieu thereof:

ARTICLE III

The maximum number of shares which the corporation is authorized to have outstanding is 15,000 common shares of the par value of 1/3 of \$1.00 a share. Each of the 500 common shares (both issued and unissued) with a par value of \$1 a share which the corporation had authority to issue immediately prior to the taking effect of this amendment is hereby changed into thirty common shares with a par value of 1/3 of \$1.00 a share.

The foregoing amendment was adopted on February 6, 2007 by the unanimous vote of all stockholders and Directors.
