


We never received our annual report that is required to be filed by May 1, 2000. All information is the same as the prior year with respect to the Officers and Directors of the Company.

We are in receipt of your package containing the renewal of our annual report/uniform business report. I apologize for the oversight of not signing the document. It is now signed.


