ARTICLES OF AMENDMENT TO THE CERTIFICATE OF  
INCORPORATION OF

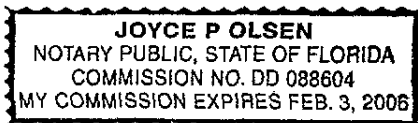
